We're dedicated to pursuing civil lawsuits against entities such as motels, schools, camps, transportation companies, and other institutions to hold them accountable for their role in sex abuse and sex trafficking. Our primary goal is to provide you support, seek justice, and to disrupt the foundations that enable abuse.

WHO WE HELP:

Survivors of human trafficking or sexual assault of all ages and gender are encouraged to come forward.

HOW WE HELP:

Understanding the timeframe of the incident is crucial due to statute of limitations considerations.

During the attorney introductory meeting, we will assess the eligibility of your case.

Deadlines for legal action vary by state.



Open Communication

We encourage you to share your experiences with us openly. Your voice is crucial in building a strong case, and we're here to listen without judgment.

Active Participation

Your active involvement in providing information and documentation will help us strengthen your case. We understand that this may be emotionally challenging, and we will support you throughout the process.

Safety and Stability

While we only provide legal services, we also have a Resource Coordinator available to assist in connecting you to programs and resources for additional support. If you are ready to seek justice, we are here to support you.

WHAT TO EXPECT



- **Our First Step Towards Justice:** You'll begin by meeting with our team for an intake session over the phone. We'll ask you some questions, listen to you, and discuss the attorney client agreement.
- **Building Together:** Soon after, you'll have a call with our trusted attorneys where we can elaborate on case-specific facts, timelines, and address your concerns. We understand that discussing such sensitive matters can be challenging, and we are available to meet via Zoom, phone, or in person.
- **Strength and Support:** Together, we'll work on gathering the necessary documents and information to build your case. This process may evoke difficult memories, and we'll handle your information with care and confidentiality.
- **Communication and Trust:** Our attorneys and legal team will diligently work on your case with the aim of preparing it for mediation or trial. While the duration of cases can vary, we'll keep you informed with regular updates and address your concerns as they may arise.
